Mayor Pro Tempore/Agency Vice Chairman/Authority Vice Chairman Hilton pulled Item No. 18 for discussion and wanted to know why the contracts are being split between two contractors and why University Drive was not being addressed.

Director Rodgers addressed Mayor Pro Tempore/Agency Vice Chairman/Authority Vice Chairman, Dr. Hilton's concerns and dividing the city in half provides the best resources for the city to provide the level of care the city once had. He stated once contracts are awarded, Public Works will meet with both vendors to address problem areas and make sure all areas are addressed and adjustments will be made as needed.

Mr. Zeke Swayzer was asked to speak in response to Council Member/Agency Member/Authority Board Member Dear's questions about the work. He discussed his contract.

Mayor/Agency Chairman/Authority Chairman Davis-Holmes noted once the contracts are complete and the city is brought back to its original standard, the city will return to one contract which the City Manager confirmed.

Council Member/Agency Member/Authority Board Member Hicks thanked Mr. Swayzer for his work.

City Manager Roberts, Jr. explained that a change order can be submitted at a later time but to adhere to the procurement process that has already transpired.

Discussion ensued regarding the terms of the contracts.

Mayor Pro Tempore/Agency Vice Chairman/Authority Vice Chairman, Dr. Hilton withdrew his motion.

New Main Motion

It was moved to approve staff recommendations on motion of Hilton, seconded by Hicks.

Substitute Motion

During discussion of the new main motion, Council Member/Agency Member/Authority Board Member Dear offered a substitute motion to reject all bids and keep Swayzer Corporation to continue doing the work and rebid entire process and have one company to work on the whole city at a cost efficient for taxpayers and seconded by Hilton.

During discussion of the substitute motion, Mayor Pro Tempore/Agency Vice Chairman/Authority Vice Chairman, Dr. Hilton stated Swayzer Corporation does not want to hold up the process for the city. If done all over again, it will take another six months of no work being done.

Mayor Pro Tempore/Agency Vice Chairman/Authority Vice Chairman, Dr. Hilton withdrew his second to the substitute motion.
