

## **RESOLUTION NO. 23-038**

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF CARSON, CALIFORNIA, AMENDING THE CLASSIFICATION PLAN, RESOLUTION NO. 77-111, BY ADOPTING THE JOB SPECIFICATION AND SALARY FOR PUBLIC INFORMATION ANALYST

**WHEREAS**, Section 503 of the City's Charter provides that the City Council shall determine, by ordinance or resolution, the amount and type of compensation to be paid to all City officers, department heads and employees; and

**WHEREAS**, The Assistant City Manager is authorized and directed under provisions of Sections 2797.1 of the Carson Municipal Code and Section II, Rule II of the City Personnel Rules to prepare and recommend position classification and compensation plans, after consultation with the affected Directors, which becomes effective upon approval by the City Council; and

**WHEREAS**, Rule III of the City of Carson Personnel Rules provides that modification to the classification plan, embodied in Resolution No. 77-111, shall be made only after the authorized Human Resources staff members consults with the affected Directors and affected recognized employee organizations; and

**WHEREAS**, The City has reviewed the needs and services of the Public Information Division and determined that, to improve its services to the public and efficiency of the Public Information Division, the City of Carson desires to add a new classification specification of **PUBLIC INFORMATION ANALYST** to ensure the service and efficiencies.; and

**WHEREAS**, The Director of Human Resources has consulted with the affected parties and has met and conferred with the representatives of the affected recognized employee organizations pursuant to its obligations under the MMBA, concerning the new classification specification for the **PUBLIC INFORMATION ANALYST**.

**NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF CARSON, CALIFORNIA, DOES HEREBY RESOLVE, DECLARE, DETERMINE AND ORDER AS FOLLOWS:**

**SECTION 1.** The foregoing recitals are true and correct and are incorporated herein by reference.

**SECTION 2.** The new classification specification for **PUBLIC INFORMATION ANALYST**, Salary Range 903, (\$7,056 – \$9,005), assigned to the Carson Professions and Supervisors Association/SEIU 721, is hereby adopted.

**SECTION 3.** City will fund one full-time position for the newly adopted classification of **PUBLIC INFORMATION ANALYST**.

**SECTION 4.** In the event of any conflict between this Resolution and any prior City resolution relating to the subject matter hereof, this Resolution shall supersede and prevail over the prior resolution to the extent of the conflict.

**SECTION 5.** The City Clerk shall certify to the adoption of this resolution and deem it effective as of February 7th of 2023 the same shall be in force and effect.
