### **MINUTES CARSON CITY COUNCIL SPECIAL MEETING AUGUST 15, 2023 4:00 P.M.**

#### **CALL TO ORDER:**

The meeting was called to order at 4:05 P.M. by Mayor Lula Davis-Holmes in the Helen Kawagoe Council Chambers, Carson City Hall, located at 701 E. Carson Street, Carson, California 90745.
