

RESOLUTION NO. 21-072

**A RESOLUTION OF THE CITY OF CARSON CITY COUNCIL
AMENDING THE FISCAL YEAR 2020-21 BUDGET IN THE GENERAL
FUND**

WHEREAS, the City Council adopted the Fiscal Year 2020-21 (FY20-21) budget on June 16, 2020 for the General Fund & Special Revenue Funds of the City via Resolution No. 20-089; and

WHEREAS, the federal government passed the Middle Class Tax Relief and Job Creation Act of 2012, which included a section related to public safety radio communications and mandated that by 2023, public safety agencies would have to abandon the UHF frequency spectrum currently used and move to a different spectrum.

WHEREAS, the City of Carson UHF radio system that supports public safety and public works will begin transitioning to the Los Angeles Regional Interoperability Communication System (LA-RICS) in 2021-2022;

WHEREAS, the Emergency Services Section of the City Manager's Dept. has initiated the Radio Project which will allow communication compatibility between city partners such as the Sheriff's Department, Fire Department, and CSU Dominguez Hills.

WHEREAS, the City Council has determined to amend the FY 2020-21 General Fund budget to fund the Radio Project.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF CARSON DOES HEREBY RESOLVE, FIND, DETERMINE, AND ORDER AS FOLLOWS:

Section 1. The following amendment(s) will be made to the City's FY 2020-21 General Fund budget:

Transfer from account no. 101-55-593-133-6004 = (\$307,459.14)

Transfer from account no. 101-50-501-100-6056 = (\$144,000.00)

Transfer to account no. 101-55-593-138-6004 = \$451,459.14

Section 2. The City Clerk shall certify to the adoption of this resolution and shall keep a copy of this resolution attached to the Fiscal Year 2020-2021 budget on file, and effective as of June 15, 2021 the same shall be in force and effect.
