What is TAP?

RPOSD's Technical Assistance Program (TAP) offers information, tools, resources, and strategies to help applicants through all stages of a project, from conceptualization, through grant initiation, grantmaking, and project completion.

What is the goal?

The goal of TAP is to achieve park/open space equity by supporting the development of park and open space grant applications that result in more high-quality parks in communities that have been identified as High-Need or Very-High-Need in the LA County Park Needs Assessment.

Who's eligible for TAP?

Some TAP resources are available to all grant applicants through all stages of their proposed park project or program. However, applicants with projects located in High-Need or Very-High-Need Study Areas have access to additional park development consulting services.

What Next?

If your entity is in a park high-need or very-high-need area, you may be eligible for TAP Professional Consulting Services.
