

The City's Municipal Code ("CMC") enables the City to exercise Piggyback Purchasing (Sec. 2611(f)) for services without complying with the bidding or proposal procedures from any vendor who offer the services or professional services at the same or better price, terms, and/or conditions as the supplier previously offered to another city or other public agency. The City of Torrance, California issued RFP B2022-25 for Graffiti Removal Services in May of 2022, with a proposal deadline of May 23, 2022. As a result, the City of Torrance awarded Contract to Graffiti Protective Coatings, Inc. ("GPC"), whom currently runs a highly successful graffiti abatement service with a zero tolerance daily goals, innovative software that provides real-time Customer Relationship Management ("CRM") through smartphones, and expert color matching.

The City of Carson is seeking to piggyback off of the City of Torrance's formal RFP B2022-25 and the resulting contract in an effort to introduce a similar operation to the Carson Community. The resulting City of Carson contract will include competitive pricing for labor, materials, supplies, and equipment required to conduct graffiti abatement throughout the Carson Community.
