

RESOLUTION NO. 23-157

A RESOLUTION OF THE CARSON CITY COUNCIL  
REALLOCATION OF ARPA FUNDED PROJECTS TO SMALL  
BUSINESS GRANT PROGRAM (SBGP).

WHEREAS, the City Council adopted the City’s Fiscal Year (FY) 2023-24 budget on June 20, 2023; and

WHEREAS, the City wishes to reallocate ARPA funds financing certain projects to Small Business Grant Program.

WHEREAS, the City Council desires to amend FY 2023-24 budget to authorize using General Fund money to replace ARPA funding for projects affected by reallocation of ARPA funds.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF CARSON DOES HEREBY RESOLVE, FIND, DETERMINE, AND ORDER AS FOLLOWS:
