

RESOLUTION NO. 22-227

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF CARSON, CALIFORNIA, APPROVING THE SUCCESSOR MEMORANDUM OF UNDERSTANDING BETWEEN THE CITY OF CARSON AND THE ASSOCIATION OF MANAGEMENT EMPLOYEES, FOR THE PERIOD OF JULY 1, 2021 to JUNE 30, 2024

WHEREAS, the City of Carson (City) has and continued to recognize the Association of Management Employees (AME) as the sole exclusive bargaining agents for those City employees designated as being in the Association of Management Employees (AME), for all matters concerning wages, hours and working conditions; and

WHEREAS, the most current Memorandum of Understanding (MOU) expired between the City and AME expired on June 30, 2021;

WHEREAS, the City labor relations representatives and AME representatives successfully met and conferred to negotiate a successor MOU between the parties pursuant to both the Meyers-Milias-Brown Act (MMBA) (Government Code Sections 3500- 3511) and the City's Employer-Employee Relation Resolution No. 85-107 (EERR), and jointly prepared and executed a Tentative Agreement dated October 18, 2022 for a successor memorandum of understanding (Tentative Agreement), which was approved by City Council as Resolution No. 22-219 on October 18, 2022; and

WHEREAS, the City labor relations representatives and AME representatives subsequently met and conferred to negotiate the successor MOU between the parties pursuant to the MMBA, the City's Employer-Employee Relation Resolution No. 85-107, and Resolution No. 22-227 dated November 1, 2022, and jointly prepared and executed the attached successor AME MOU 2021-24; and

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF CARSON DOES HEREBY RESOLVE, FIND, DETERMINE, AND ORDER AS FOLLOWS:

Section 1. The above recitals are true and correct.

Section 2. The City Council approves the successor AME MOU 2021-24 between the City and AME for the period of July 1, 2021, through and including June 30, 2024, a copy of which is attached as Attachment 1.

Section 3. The City Clerk shall certify to the passage and adoption of this Resolution and enter it into the book of original resolutions.

Section 4. This resolution shall be effective immediately upon its passage and adoption.
