

**RESOLUTION NO. 22-241**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF CARSON, CALIFORNIA, AMENDING THE FISCAL YEAR 2022-23 BUDGET, IN THE CITY MANAGER’S OFFICE, FOR THE ADJUSTMENT OF SALARIES AND BENEFITS OF PERSONNEL RESULTING FROM AMENDMENTS TO THE COMPENSATION AND BENEFITS RESOLUTIONS FOR FULL-TIME TIME AND PART-TIME COUNCIL AIDES AND CHIEF DEPUTY CITY CLERK AND CHIEF DEPUTY CITY TREASURER**

**WHEREAS**, the City Council adopted the City’s Fiscal Year (FY) 2022-23 budget on June 21, 2022; and

**WHEREAS**, the City of Carson desires to increase salaries for full time and part time Council Aides and amend certain benefits for full time Council Aides;

**WHEREAS**, the City Council desires to amend FY 2022-23 budget to authorize the use of funds from the Unreserved General Fund and Special Revenue and to appropriate additional salaries, retirement benefits, and Medicare benefits in each of the effected Department operating budgets.

**NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF CARSON DOES HEREBY RESOLVE, FIND, DETERMINE, AND ORDER AS FOLLOWS:**
