RESOLUTION NO. 23-149

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF CARSON, CALIFORNIA, AMENDING RESOLUTION NO. 23-075 TO CORRECT THE LISTED SALARY TABLES FOR THE CLASSIFICATIONS OF CHIEF DEPUTY CITY CLERK AND CHIEF DEPUTY CITY TREASURER

WHEREAS, on June 21, 2016, the City Council formally created a new unrepresented, non-classified, at-will position of employment, subject to the appointing authority of the City Clerk of the City pursuant to Government Code Section 40813, under the title of "Senior Deputy City Clerk."

WHEREAS, by adoption of Resolution No. 16-075 on June 21, 2016, the City Council adopted classification specifications for the Senior Deputy City Clerk position.

WHEREAS, the Senior Deputy City Clerk position received a 2% salary increase, effective July 1, 2018.

WHEREAS, the City Council, by adoption of Resolution No. 19-036 in 2019, changed the title of the "Senior Deputy City Clerk" position to "Chief Deputy City Clerk."

WHEREAS, also by adoption of Resolution 19-036 in 2019, the City Council approved the creation of a new unrepresented, non-classified, at-will position of employment under the title of "Chief Deputy City Treasurer," which position is subject to the appointing authority of the City Treasurer of the City, pursuant to Government Code Sections 41006 and 41007.

WHEREAS, on March 19, 2019, the City Council adopted Resolution No. 19-045 amending and restating Resolution No. 77-111, adopting classification specifications for the Chief Deputy City Clerk and Chief Deputy City Treasurer positions.

WHEREAS, on April 18, 2023, the City Council adopted Resolution No. 23-075, amending Resolution No. 19-045 to retroactively increase the salaries for the classifications of Chief Deputy City Clerk and Chief Deputy City Treasurer to reflect cost of living adjustments consistent with other employees in the City. However, the adjusted salary tables that were listed in Section 3 of Resolution No. 23-075 were erroneous in that they did not correctly reflect the substantive salary increases that were approved and intended pursuant to said resolution (see Section 2 thereof). As such, the City Council now desires to amend Section 3 of Resolution No. 23-075 to correct said salary tables in order to avoid any confusion, although payment has at all relevant times been made properly in accordance with the substantive approval given and intended by said resolution, consistent with the correct salary tables set forth hereinbelow. The Assistant City Manager has consulted with the affected parties to the extent required by law.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF CARSON, CALIFORNIA, HEREBY FINDS, DETERMINES AND RESOLVES AS FOLLOWS:

- **Section 1.** The above recitals are true and correct, and are incorporated herein by this reference.
- **Section 2.** The salary tables set forth in Section 3 of Resolution No. 23-075 are hereby replaced in their entirety with the following:
