

RESOLUTION NO. 23-186

**A RESOLUTION OF THE CITY OF CARSON CITY COUNCIL AMENDING THE FISCAL YEAR 2023-24 BUDGET
IN THE GENERAL FUND AND SPECIAL REVENUE FUNDS**

WHEREAS, on November 7th, 2023, City Council approved award of four annual pavement maintenance contracts, and the approved contracts warranted the need to amend the adopted Fiscal Year 2023-2024 (FY2023-24) budget by \$8,000,000; and

WHEREAS, Resolution No. 23-160 was presented in conjunction with the pavement contract awards, and stated an amended budget of \$12,000,000 for the pavement contract awards; and

WHEREAS, it is necessary to correct the stated amended budget amount; and

WHEREAS, the City Council adopted the FY2023-24 budget on June 20, 2023 for the General Fund and Special Revenue Funds of the City via Resolution No. 23-095; and

WHEREAS, the City Council desires to amend the FY2023-24 budget; and

WHEREAS, the City Council has determined it necessary to amend the FY2023-24 General Fund and Special Revenue Funds budget.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF CARSON DOES HEREBY RESOLVE, FIND, DETERMINE, AND ORDER AS FOLLOWS:

Section 1. The following amendment(s) will be made to the City's FY2023-24 budget.
