

RESOLUTION NO. 22-039

A RESOLUTION OF THE CITY OF CARSON CITY COUNCIL APPROPRIATION OF AMERICAN RESCUE PLAN ACT FUNDS

WHEREAS, the American Rescue Plan Act provides Coronavirus State and Local Fiscal Recovery Funds (SLFRF) to local governments such as the City of Carson to address immediate and emergency needs related to COVID-19, including replenishing staffing shortages, premium pay for employees and elected officials who worked during the pandemic, providing infrastructure and capital improvements, and assistance for local business and residents; and

WHEREAS, in addition to expenditures on City infrastructure and capital improvements and other allowable expenditures to improve the community and provide for residents, the City desires to utilize a portion of the SLFRF to provide premium pay for employees and elected officials who worked at City facilities during the pandemic and who are currently employed by the City, and

WHEREAS, the City Council has determined it necessary to amend the FY 21-22 Budget to provide for premium pay through the SLFRF received by the City.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF CARSON DOES HEREBY RESOLVE, FIND, DETERMINE, AND ORDER AS FOLLOWS:

Section 1. The following SLFRF allocations are as follows thereby amending the City's FY 21-22 budget.
