A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF CARSON, CALIFORNIA, APPROVING **PROGRAM** SUPPLEMENT NO. A523 TO ADMINISTERING AGENCY-STATE AGREEMENT FOR STATE-FUNDED PROJECTS NO. FOR 07-5403S21 THE PROJECT APPROVAL & ENVIRONMENTAL DOCUMENT PHASE OF FEDERAL **PROJECT NO. ATPL-5403(032): CITY-WIDE COMMUNITY** SAFETY IMPROVEMENTS

WHEREAS, Caltrans and the City of Carson ("City") are required by the Federal Highway Administration to execute a Program Supplement Agreement to the Master Agreement Administering Agency-State Agreement State-Funded Projects (Agreement No. 07-5403S21) for Project No. 1534: City-Wide Community Safety Improvements.

WHEREAS, Program Supplement No. A523 to Administering Agency-State Agreement for State Funded Projects No. 07-5403S21 will permit the City to be reimbursed as specified in the agreement with Active Transportation Program (ATP) state fund money for the Project Approval & Environmental Document (PA&ED) phase of Carson's City-Wide Community Safety Improvements project for various intersections throughout the City of Carson and Santa Fe Avenue between 218<sup>th</sup> Place and Del Amo Boulevard.

## NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF CARSON DOES HEREBY FIND, DETERMINE, AND RESOLVE AS FOLLOWS:

Section 1. Recitals. The foregoing recitals are true and correct and are incorporated herein by this reference.

<u>Section 2</u>. Approval of Program Supplement Agreement. The City Council hereby approves the Program Supplement No. A523 to Administering Agency-State Agreement for State Funded Projects No. 07-5403S21 and authorizes the Mayor to execute this Resolution.

<u>Section 3</u>. Further Acts. The City Manager, Director of Public Works and City Clerk are hereby authorized and directed to execute such other documents and certificates, and to perform such other acts and deeds, as may be necessary or convenient to effect the purposes of this Resolution and the transactions herein authorized.

<u>Section 4</u>. Severability. The City Council declares that, should any provision, section, paragraph, sentence or word of this Resolution be rendered or declared invalid by any final court action in a court of competent jurisdiction or by reason of any preemptive legislation, the remaining provisions, sections, paragraphs, sentences or words of this Resolution as hereby adopted shall remain in full force and effect.

Section 5. Certification. The City Clerk shall certify to the passage and adoption of this Resolution and enter it into the book of original Resolutions.

Section 6. Effective Date. This Resolution shall be effective immediately upon its adoption.
