

RESOLUTION NO. 21-032

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF CARSON, CALIFORNIA, RESCINDING RESOLUTION NOS. 09-130, 10-007, 12-112, 13-045, 13-066 AND 19-026, THEREBY ELIMINATING THE CARSON HISTORICAL COMMITTEE

WHEREAS, the City Council of the City of Carson, a charter city (“City”), has broad authority under state law and the City’s Charter to establish and appoint commissions, boards and committees as part of the sub-government of the City, and to eliminate such commissions, boards and committees at its discretion; and

WHEREAS, the City Council established the Carson Historical Committee (“Committee”) in 2009 by Resolution No. 09-130, expanded the membership of the Committee in 2010 by Resolution No. 10-007, made amendments regarding the composition of the committee in 2012 by Resolution No. 12-112, made further amendments regarding the composition of the Committee in 2013 by Resolution No. 13-045, made further amendments regarding the process to remove members of the Committee in 2013 by Resolution No. 13-066, and made final amendments to reduce the membership of the Committee to five members and no alternate members and to set the term of the members serving on the Committee by Resolution No. 19-026 (collectively, when combined with all other Resolutions, if any, that may have been adopted by the City Council resulting in an amendment of Resolution No. 09-130, “Committee Resolutions”); and

WHEREAS, the City Council has determined that it is in the best interest of the City to eliminate the Carson Historical Committee and now sees fit to do so.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF CARSON, CALIFORNIA, DOES HEREBY RESOLVE, DECLARE, DETERMINE AND ORDER AS FOLLOWS:

SECTION 1. The foregoing recitals are true and correct and are incorporated herein by reference.

SECTION 2. The City Council hereby rescinds in their entirety the Committee Resolutions thereby eliminating and dissolving the Carson Historical Committee.

SECTION 3. The City Council declares that, should any provision, section, paragraph, sentence or word of this Resolution be rendered or declared invalid by any final court action in a court of competent jurisdiction or by reason of any preemptive legislation, the remaining provisions, sections, paragraphs, sentences or words of this Resolution as hereby adopted shall remain in full force and effect.

SECTION 4. The City Clerk shall certify to the adoption of this Resolution and enter it into the book of original Resolutions.

SECTION 5. This Resolution shall take effect immediately upon its adoption.
