Mayor Robles announced that a Press Conference will be held at City Hall on Thursday, April 16, 2020 at 10:00 A.M.

Mayor and City Council addressed comments made during oral communication addressing plans and ideas to assist with concerns of the residents.

Captain Skeen reported on the following:

- Deputies responded to the first death related to COVID-19 in the community. The deceased was elderly.
- The Sheriff ordered that all department personnel take every precaution to wearing face masks/coverings while interacting with the public on duty.
- Face Mask issuance program led by the City in collaboration with LASD.

**COVID-19 UPDATE (CITY COUNCIL)**

Assistant City Manager Raymond spoke about the lending program, loans and grants to assist Carson small businesses.

Director Naaseh stated notices will be sent to business owners regarding price gouging protections for tenants against unwarranted rent increases for residential and commercial tenants. In addition, a notice will be sent to all mobile home residents advising that the City will not grant any rent increases during the declared local emergency. Lastly, the notices will include information about the Carson Essentials Grocery program.
