Item No. 6. 2021-690 REPORT FROM CAPTAIN JONES OF CARSON SHERIFF'S STATION

Captain Jones reported/announced the following:

- Met with other city leaders at the Educational Summit
- Driving under the influence (DUI) Checkpoint held Friday, September 10, 2021
- Continued meetings with Emergency Services Manager Raymond Cheung and staff for planning and ready Carson alert meetings
- Participating in the Leaders of Preparedness Academy Crime Prevention Discussion on September 22, 2021, at the Carson Community Center
- Participating in the Block Captain Appreciation event on Saturday, 25, 2021
- Carson Coffee with the Station on Tuesday, September 28, 2021
- Contact the Community Relations Office for information
- Deputies continue to patrol neighborhoods
- Felt earthquake last week and reminded everyone on the importance of being prepared

   secure your hazardous and movable items, strap water heater, etc. to avoid
   catastrophe and minimize damage; identify location of your gas and water shut off
   valves and have proper tool (wrench) nearby; have a disaster plan; organize and check
   disaster supplies and important documents

Mayor Pro Tem/Agency Vice Chairman/Authority Vice Chairman Dear complimented the Sheriff Department for their quick response during the earthquake.

Mayor/Agency Chairman/Authority Chairman Davis-Holmes thanked Captain Jones and the Sergeant who was Acting Captain and for his leadership while he and the Mayor were away at

a conference.

Council Member/Agency Member/Authority Board Member Hilton spoke about an incident that occurred at Stevenson Park with kids at the park. Residents were upset with the response time and asked Captain Jones to explain why the response time took the time that it did. Council Member/Agency Member/Authority Board Member Hilton stated he would like to work with the city to provide counseling for the children having questions. Captain Jones gave an overview of the incident that occurred and his Deputies response to the incident.

Mayor/Agency Chairman/Authority Chairman Davis-Holmes asked the City Manager to identify the kids who were at the park to offer them counseling. Captain Jones stated he would like to join in the counseling with the parents and children. City Manager Landers responded in the affirmative.

Council Member/Agency Member/Authority Board Member Hicks thanked Captain Jones for their response during the earthquake. He reported individuals speeding at high speeds along University Drive between Avalon Boulevard and Wilmington Avenue. There were crashes of hitting the control box and recently a power pole causing issues with AT&T. City Manager to contact Southern California Edison to repair expeditiously. He suggested more traffic lights on University Drive to curtail speed of traffic which has been going on for some time and inquired about the status of the speed apparatus. Captain Jones responded to his inquiry.

Council Member/Agency Member/Authority Board Member Hicks reported street takeovers that are still occurring on Dominguez Street and Santa Fe Avenue. He asked the City Manager to look into cameras at intersections and hotspots. He also reported there are a lot of abandoned vehicles at Matcool Street and Sepulveda Boulevard at the 405 Freeway underpass location. Captain Jones stated he would look into the abandoned vehicles.

# Item No. 7. 2021-670 REPORT FROM CHIEF BENNETT, LOS ANGELES COUNTY FIRE DEPARTMENT

Chief Brian Bennett introduced himself stepping in for Chief Scott Hale who will be retiring after 35 years of service. He gave a report through August for run totals and response times. He spoke about the recent earthquake, surveyed the district, and found no major infrastructure damage. Preparation is key.

Chief Bennett stated he visited City Hall to pick up the clocks to be presented for the Baby Maddy Run. He stated local firefighters responded to a near drowning of Maddy. He thanked the city for the recognition and accolades on behalf of all the firefighters who were on the rescue call. He stated he would personally present the clocks to each of the six firefighters who were on the call.

Mayor and City Council thanked the Fire Department for the service they provide to the Carson area and saving Maddy's life a few weeks ago.

City Manager Landers acknowledged Chief Scott Hale's upcoming retirement and will invite him to a future City Council meeting.

Council Member/Agency Member/Authority Board Member Hicks asked about the fundraiser for Fill the Boot. Chief Bennet responded the fundraiser is usually held in February and decided not

to go forward in 2021 and will possibly be held in February of 2022.

# ORAL COMMUNICATIONS FOR MATTERS LISTED ON THE AGENDA (MEMBERS OF THE PUBLIC)

Chief Deputy City Clerk/Chief Deputy Agency Secretary/Chief Deputy Authority Secretary Carroll, Sr. presented the following comments that were submitted electronically:

### Kay Campbell - Item No. 26

Asked the City Council to enlighten the community if the Emergency Operations Plan will include how plans/communication flows between the Sheriff's Station, the local Fire Department and City Hall once a local emergency (such as fire or earthquake) is declared?

City Manager Landers noted Kay Campbell's request has been addressed by staff.

Ricardo Pulido, Environmentalist/Commissioner/Long time Carson Homeowner - Item No. 11 Reminded Mayor Lula Davis-Holmes that when Hispanic Heritage Month is celebrated to not "politicize" and turn celebration into an illegal political event clearly in violation of the Fair Political Practices Commission (FPPC) laws and Carson Code of Ethics. No political propaganda can be handed out on public property; stated he witnessed and has evidence of Freddie Gomez and his team illegally handing out to him and the audience a green political brochure at Foisia Park on September 18, 2021. He requested the City Attorney, the City Clerk's office, and the City Council to investigate this violation by the next City Council Meeting. He stated Freddie Gomez does not deserve the proclamation.

# Ricardo Pulido, Environmentalist/Commissioner/Long time Carson Homeowner/Community Advocate - Item No. 18

Need to include community residents, pillars of the community, stakeholders, and not continue to Gerrymander any Carson districts; must have open townhall meetings, zoom meetings, and community surveys with responses that must be presented from the community that will include input and best representation that will have true, fair, and honest representation for Carson. The Ad-hoc Committee needs to be ethnically diverse, equitable, and inclusive; appoint more residents now.

Mayor Pro Tem/Agency Vice Chairman/Authority Vice Chairman Dear noted staff will be hosting several community meetings regarding redistricting.

### Ricardo Pulido, Commissioner/Homeowner over 35 years - Item No. 19

Requested a comprehensive review and evaluation of the Public Works Office. What is Director Eliza Jane Whitman and her team currently working on for all, i.e., street slurries, tree trimming,

identifying safe infrastructure plan, curb, and sidewalk repairs? The city is top heavy and needs more union rank and file workers from the city (residents) who can get the job done. Do not hire and outsource any more work to consultants/contractors.

### Ricardo Pulido, Activist - Item No. 22

City needs to extend and expand the tree trimming services in Carson; need to create jobs for youth to be trained and paid part-time and full-time in landscaping, gardening, planting Carson trees and beautify Carson; need to reactivate the Environmental Commission to plan a fair and inclusive Beautification Public Arts Project for all of Carson.

### Liz Foisia - Non Agenda Item

Inquired if the City sponsored the Hispanic Heritage Month Celebration at Foisia Park on Saturday, September 18, 2021. If so, did the City also sponsor the candidacy of Freddie Gomez who is running for the City Council seat in District 4? There was a definite appearance of City Council endorsement for Mr. Gomez who had free rein to campaign at the Hispanic Heritage Month Celebration at Foisia Park. Especially since there was public notice for this event distributed by the City with the entire City Council photos on the notice; referred to the Mayor's behavior at the September 7, 2021 City Council meeting violating the Council Rules of Decorum despite the City Attorney's attempt to intervene the Mayor Pro Tem's and Mayor's comments to each other.
