

RESOLUTION NO. 19-048

A RESOLUTION OF THE CARSON CITY COUNCIL AMENDING THE FISCAL YEAR 2018/19 ADOPTED BUDGET APPROVING FUNDS FOR THE PURCHASE OF SIGNAGE AND PLAQUES, AND HOLD A DEDICATION CEREMONY FOR THE NEW JAMES M. FOISIA PARK

WHEREAS, the City Council adopted the City's Fiscal Year (FY) 2018-19 budget on June 19, 2018; and

WHEREAS, at the October 16, 2018, City Council meeting, former-Councilmember Santarina proposed renaming Scott Park, Foisia Park in honor of James M. Foisia; and

WHEREAS, the City Council directed the Parks and Recreation Commission to hold two (2) meetings to gauge public sentiment on this proposal. As a result of strong community support, the Parks and Recreation Commission approved renaming General Scott Park to James M. Foisia Park; and

WHEREAS, the City Council approved the Commission's recommendation at its December 4, 2018, meeting; and

WHEREAS, the City Council directed staff to prepare an estimate of the cost of purchasing signage and plaques, and holding a dedication ceremony; and

WHEREAS, the City Council desires to amend the FY 2018-19 budget to allocate funds in the amount of \$21,000.00 for the these items.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF CARSON DOES HEREBY RESOLVE, FIND, DETERMINE, AND ORDER AS FOLLOWS:

Section 1. The following amendments will be made to the City's budget:
