RESOLUTION NO. 24-058

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF CARSON, CALIFORNIA, AUTHORIZING THE DESTRUCTION OF SPECIFIED CITY RECORDS WITHIN THE CITY CLERK'S OFFICE

WHEREAS, the City Clerk's Office has in storage a variety of records dating from 1970 to 2022; and

WHEREAS, Title 4, Division 1, Chapter 1, Article 4, Section 34090 of the California Government Code, provides that, with the approval of the legislative body by resolution and written consent of the city attorney, the head of a city department may destroy any city record, document, instrument, book, or paper, under the department head's charge, without making a copy thereof, after the same is no longer required; and

WHEREAS, the City Clerk, as the head of the City Clerk's Office, has approved the proposed destruction of records itemized in Attachment "A" of this Resolution as the records have met their retention requirement and are not the subject of any claim, litigation, investigation or audit, and are no longer of any public use and possess no historical or legal value; and

WHEREAS, the City Clerk and the City Attorney have reviewed and approved the proposed destruction of the records itemized in Attachment "A" of this Resolution and determined that such destruction is consistent with applicable state law.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF CARSON, CALIFORNIA, DOES HEREBY RESOLVE AS FOLLOWS:

SECTION 1. The recitals above are true and correct and are incorporated herein by this reference.

SECTION 2. The City Council hereby approves and authorizes the destruction of the records listed in Attachment "A" to this Resolution.

<u>SECTION 3</u>. The City Council declares that, should any provision, section, paragraph, sentence or word of this Resolution be rendered or declared invalid by any final court action in a court of competent jurisdiction or by reason of any preemptive legislation, the remaining provisions, sections, paragraphs, sentences or words of this Resolution as hereby adopted shall remain in full force and effect.

SECTION 4. The City Clerk shall certify to the adoption of this Resolution and enter it into the book of original Resolutions.

SECTION 5. This Resolution shall take effect immediately upon its adoption.
