

AMENDMENT NO. 2

TO AGREEMENT FOR CONTRACT SERVICES

THIS AMENDMENT TO THE AGREEMENT FOR CONTRACT SERVICES (“Amendment”) by and between the CITY OF CARSON, a California municipal corporation (“City”) and SDI PRESENCE, LLC, a Delaware limited liability corporation (“Consultant”) is effective as of the 17th day of September, 2019.

RECITALS

- A. City and Consultant (formerly known as NexLevel Information Technology, Inc.) entered into that certain Agreement for Contractual Services dated February 21, 2017, (“Agreement”) whereby Consultant agreed to provide Professional Project Management Services (Tyler Munis implementation).
- B. The City and Consultant executed Amendment No. 1 to the Agreement (dated March 21, 2019) to extend the time period for performance by 180 days, so that the Agreement Term was extended to September 17, 2019.
- C. The City and Consultant wish to extend the Term of the Agreement for an additional six months, and increase the Contract Sum to authorize compensation for services rendered during the extended Term.

TERMS

1. **Contract Changes.** The Agreement is amended as provided herein (deleted text is identified in ~~strike through~~ and new text is identified in ***bold italics***):

- A. Section 2.1 (Contract Sum) is amended as follows:

Subject to any limitations set forth in this Agreement, City agrees to pay Consultant the amounts specified in the “Schedule of Compensation” attached hereto as Exhibit “C” and incorporated herein by this reference. The total compensation, including reimbursement for actual expenses, shall not exceed ~~three hundred eleven thousand eight hundred fifty Dollars (\$311,850)~~ ***Three Hundred Seventy-One Thousand Two Hundred Fifty Dollars (\$371,250)*** (the “Contract Sum”), unless additional compensation is approved pursuant to Section 1.8.

- B. Section I of Exhibit “C” – Schedule of Compensation is amended as follows:

Consultant shall perform the services at a rate of \$165 per hour. The project budget includes ~~1,890~~ ***2,250*** hours, for a total contract sum of ~~\$311,850~~ ***\$371,250***.

- C. Section IV of Exhibit “C” – Schedule of Compensation is amended as follows:

The total compensation for the Services shall not exceed ~~\$371,250~~ \$311,850, as provided in Section 2.1 of this Agreement.

D. Section I (Term) of Exhibit “D” – Schedule of Performance is amended as follows:

Unless earlier terminated in accordance with Article 7 of this Agreement, the term of this Agreement shall be end on ~~September 17, 2019~~ **March 16, 2020**.

2. **Continuing Effect of Agreement.** Except as amended by this Agreement, all provisions of the Agreement shall remain unchanged and in full force and effect. From and after the date of this Amendment, whenever the term “Agreement” appears in the Agreement, it shall mean the Agreement, as amended by this Amendment to the Agreement.

3. **Affirmation of Agreement; Warranty Re Absence of Defaults.** City and Consultant each ratify and reaffirm each and every one of the respective rights and obligations arising under the Agreement. Each party represents and warrants to the other that there have been no written or oral modifications to the Agreement other than as provided herein. Each party represents and warrants to the other that the Agreement is currently an effective, valid, and binding obligation.

Consultant represents and warrants to City that, as of the date of this Amendment, City is not in default of any material term of the Agreement and that there have been no events that, with the passing of time or the giving of notice, or both, would constitute a material default under the Agreement.

City represents and warrants to Consultant that, as of the date of this Amendment, Consultant is not in default of any material term of the Agreement and that there have been no events that, with the passing of time or the giving of notice, or both, would constitute a material default under the Agreement.

4. **Adequate Consideration.** The parties hereto irrevocably stipulate and agree that they have each received adequate and independent consideration for the performance of the obligations they have undertaken pursuant to this Amendment.

5. **Authority.** The persons executing this Agreement on behalf of the parties hereto warrant that (i) such party is duly organized and existing, (ii) they are duly authorized to execute and deliver this Agreement on behalf of said party, (iii) by so executing this Agreement, such party is formally bound to the provisions of this Agreement, and (iv) the entering into this Agreement does not violate any provision of any other Agreement to which said party is bound.

6. **Counterparts.** The terms of this Amendment may be executed in counterparts, each of which shall be deemed to be an original, and such counterparts shall constitute one and the same instrument.
