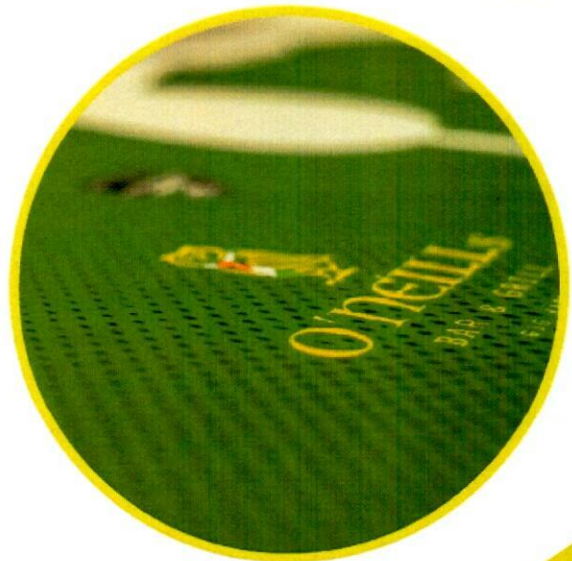

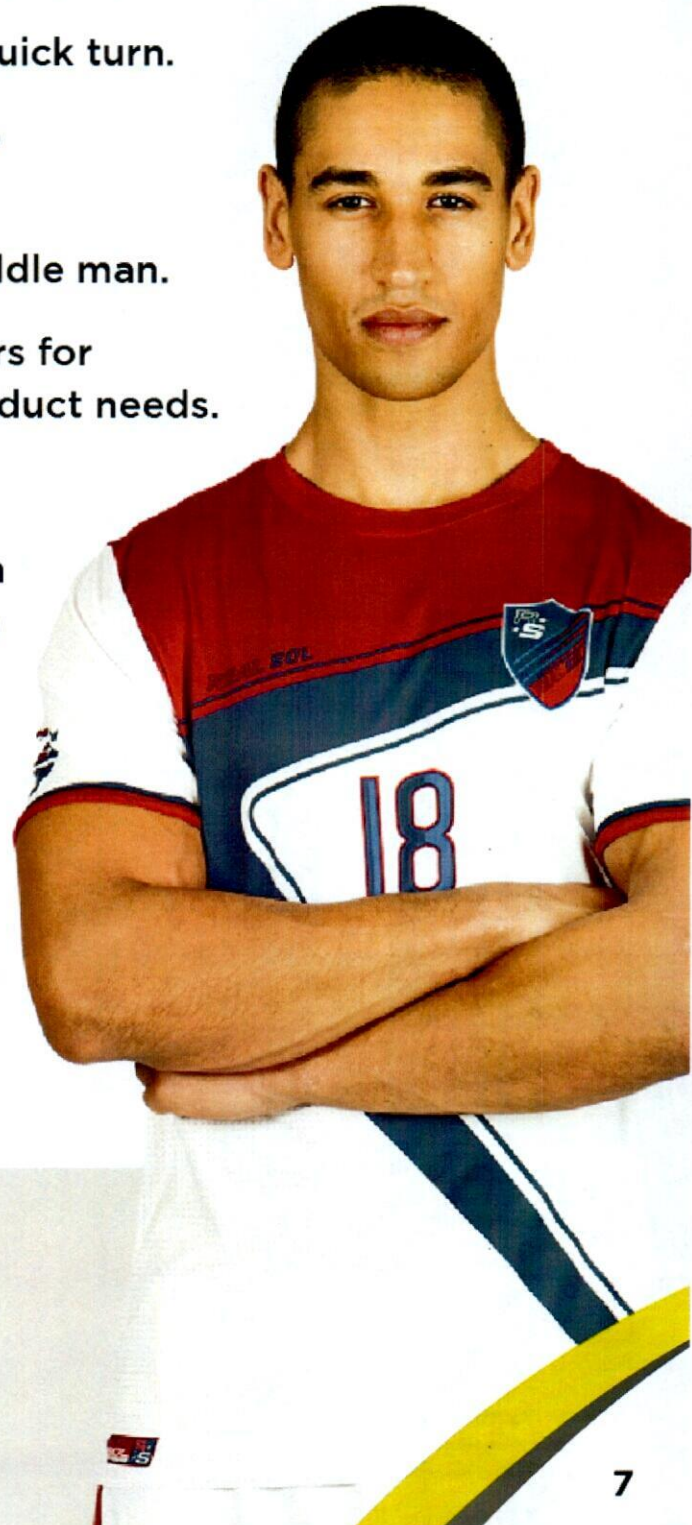

2015 - Moved into 54,000 square foot facility in Seattle. Third expansion since 2007.

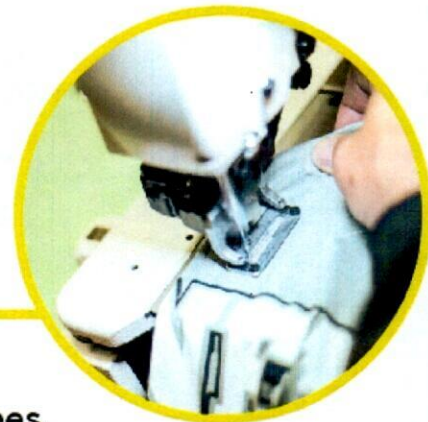

2017 - Added domestic sublimation division to further service fully custom CLUB ID brand for premier clubs.

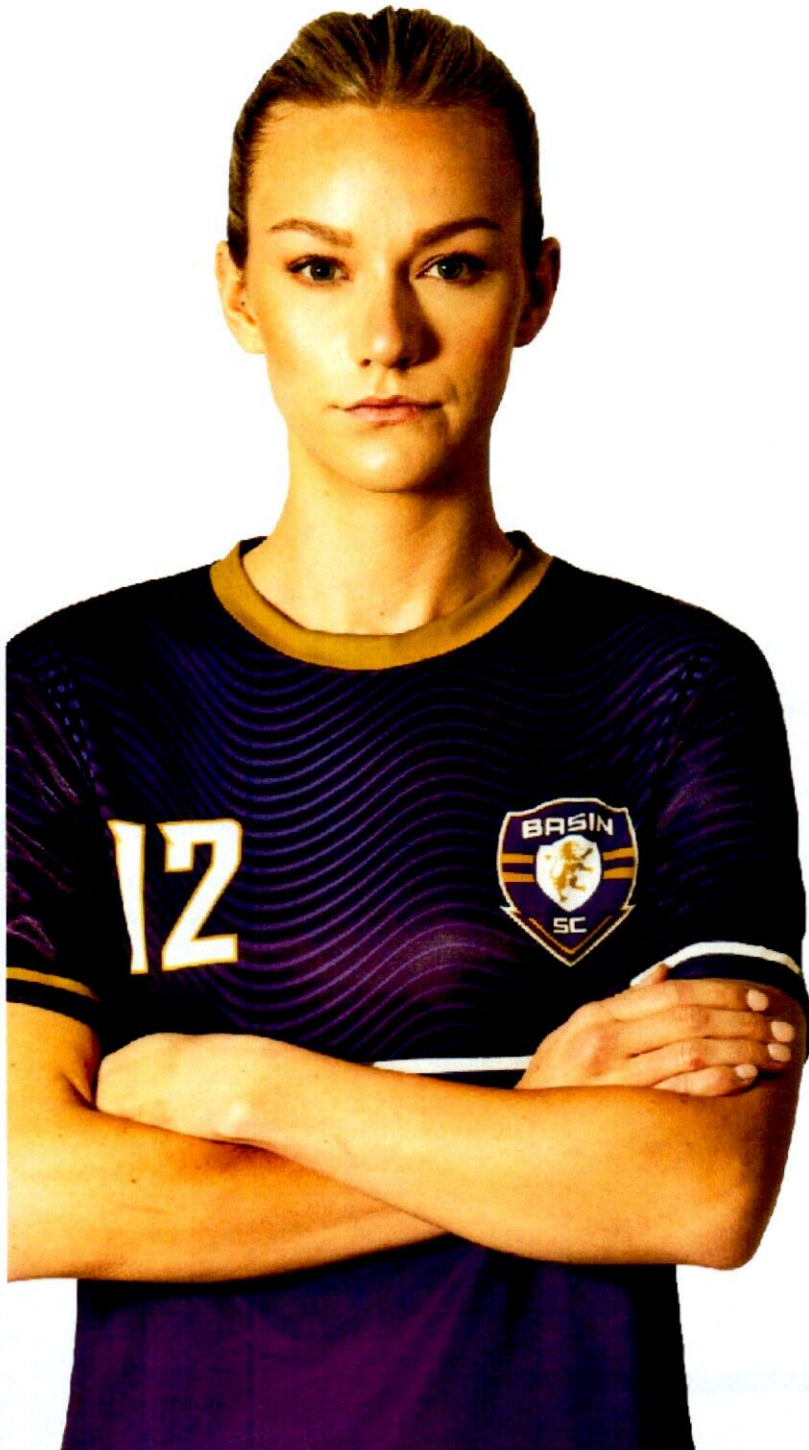



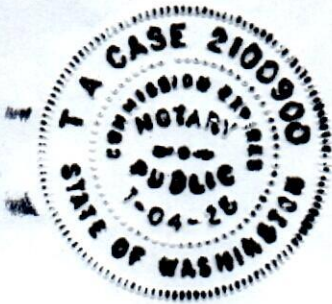
