

## **RESOLUTION NO. 23-004**

### **A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF CARSON, CALIFORNIA, AMENDING THE FISCAL YEAR 2022- 2023 BUDGET TO ACCEPT THE HAZARD MITIGATION GRANT FUNDS FOR THE UPDATE OF THE HAZARD MITIGATION PLAN**

**WHEREAS**, the City Council adopted the City' s Fiscal Year (FY) 2022- 23 budget on June 21, 2022; and

**WHEREAS**, on March 2, 2021, the City Council adopted the California Office of Emergency Services (CalOES) Form 130- Designation of Subrecipient's Agent Resolution CALOES ID No. PA00000412 for the purpose of obtaining certain federal financial assistance under Public Law 93-288 as amended by the Robert T. Stafford Disaster Relief and Emergency Assistance Act of 1988, and/or state financial assistance under the California Disaster Assistance Act; and

**WHEREAS**, the City of Carson through its Emergency Services Manager applied for a Hazard Mitigation Plan Assistance funds with the California Office of Emergency Services (CalOES); and

**WHEREAS**, on August 24, 2022, the City of Carson was awarded \$68,245.50 for the 75% federal share, plus \$2,620.58 in Management Costs as a sub-recipient of federal funds; and

**WHEREAS**, the City matched the federal funds at 25% in the amount of \$22,748.50 on Emergency Services account number 101-55-593-138-6004.

**WHEREAS**, the funds will be used to update the 2013 City's Hazard Mitigation Plan; and

**WHEREAS**, the City Council now desires to amend FY 2022- 23 budget in order to accept these funds.

**NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF CARSON DOES HEREBY RESOLVE, FIND, DETERMINE, AND ORDER AS FOLLOWS:**

**Section 1.** The general fund will be reimbursed following reimbursement from CalOES. The following amendments will be made to the City' s Fiscal Year 2023-2024 expenditure budget:
