Council Member/Agency Member/Authority Board Member Hicks noted the South Coast Air Quality Management District (AQMD) has a ruling if one has a water heater that breaks down and is non repairable that it has to be replaced with an electric water heater. The other requirement is if the furnace or heater breaks down, it cannot be repaired and has to be replaced with an electric furnace or heater effective 2028. He is concerned with the low income to middle income individuals who are not able to purchase to replace or repair them. He asked Socalgas' position on presenting to the residents on AQMD's requirements. Gabriela Medina responded to his inquiry and spoke about hydrogen blending.

Council Member/Agency Member/Authority Board Member Dear asked if one has a gas stove, what percentage of the fuel that Socalgas supplies those homes can be hydrogen in a blend situation and if proposed in the future to use 100% hydrogen. Gabriela Medina responded to his inquiry and explained the two projects of hydrogen blending.
