

RESOLUTION NO. 19-032

A RESOLUTION OF THE CARSON CITY COUNCIL AMENDING THE
FISCAL YEAR 2018-19 BUDGET IN THE TRANSPORTATION
DIVISION FOR CERTIFIED NATURAL GAS

WHEREAS, the City Council adopted the City's Fiscal Year (FY) 2018-19 budget on June 19, 2018; and

WHEREAS, The City of Carson operates the Carson Circuit, a fixed-route public transit system that services defined areas of the City; and

WHEREAS, CNG fuel used for the buses is purchased from Clean Energy Fuels Corp. (Clean Energy); and

WHEREAS, ongoing contract negotiations with Clean Energy have led to a number of invoices that have not yet been paid, and the need to establish a blanket purchase order for purchases made until the end of this fiscal year; and

WHEREAS, funds in the amount of \$152,553.73 will be used to pay invoices for the period July 2018 through December 2018, and \$168,000.00 for the period January 2019 through June 2019. This will require an additional \$45,553.73 to meet the Division's obligations until the end of the fiscal year; and

WHEREAS, the City Council desires to amend FY 2018-19 budget in order to ensure payment of these past and future invoices.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF CARSON DOES
HEREBY RESOLVE, FIND, DETERMINE, AND ORDER AS FOLLOWS:

Section 1. The following amendments will be made to the City's budget:
