

RESOLUTION NO. 24-051

A RESOLUTION OF THE CITY OF CARSON CITY COUNCIL AMENDING THE FISCAL YEAR 2023-24 BUDGET TO ACCEPT THREE GRANTS IN THE TOTAL AMOUNT OF \$875,000 IN CONNECTION WITH THE STATE OF CALIFORNIA EQUITABLE COMMUNITY REVITALIZATION GRANT (ECRG) PROGRAM

WHEREAS, the City Council adopted the Fiscal Year 2023-24 (FY 2023-24) budget on June 20, 2023; and

WHEREAS, the City of Carson submitted three competitive grant applications in connection with the State of California Environmental Protection Agency Department of Toxic Substances and Control's Equitable Community Revitalization Grant (ECRG) program; and

WHEREAS, the City of Carson was awarded and entered into three Grant Agreements to receive \$350,000 for a community wide assessment, \$150,000 for environmental investigation on the Carson Housing Authority properties located at 526 W. Carson Street and 21704 South Figueroa Street, and \$375,000 for environmental investigation on the Sywest Development property located at 20151 S. Main Street; and

WHEREAS, the City Council has determined it necessary to approve an amendment to the City's FY 2023-24 budget to account for a portion of the grant award, effective March 29, 2024.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF CARSON DOES HEREBY RESOLVE, FIND, DETERMINE, AND ORDER AS FOLLOWS:

Section 1. The following amendments will be made to the City's FY 2023-24 budget.
