**A RESOLUTION OF THE CARSON CITY COUNCIL
AMENDING THE FISCAL YEAR 2023-24 BUDGET, CITY
MANAGER'S OFFICE DEPARTMENT, FOR THE PURCHASE
OF CITY HALL OFFICE FURNITURE.**

WHEREAS, the City Council adopted the City's Fiscal Year (FY) 2023-24 budget on June 20, 2023 via Resolution No. 23-095; and

WHEREAS, the City Council desires to replace outdated and antiquated office furniture for offices throughout the second floor of city hall and the Council Aide offices;

WHEREAS, pursuant to City Purchasing Code, staff has secured a quotation from GOFORTH & MARTI, doing business as G/M Business Interiors, to furnish and install office furniture with pricing approved through the OMNI Partners, Public Sector Cooperative Contract No. 2020000608.

WHEREAS, the City Council desires to amend FY 2023-24 budget to authorize the use of funds from the Unreserved Budget and Departmental Budget Transfer to purchase furnishings for City Hall offices from GOFORTH & MARTI, doing business as G/M Business Interiors.
