- A projector screen, podium and microphone will be set up, allowing members of the public to observe the hearing (with Spanish translation) and provide public comments to the Council (with Spanish translation) in real-time.
- To prevent the spread of COVID-19, a contactless temperature screening will be performed at the entry; anyone with a temperature over 100.3 F will be required to leave the premises.
- Execution of a liability waiver and release form provided by the City related to COVID-19 will be required prior to entering the Community Center.
- Face coverings will be required at all times.
- A microphone cover will be used and changed out between speakers to ensure compliance with applicable COVID-19 sanitation protocols.
- To ensure social distancing, chairs will be spaced at least six feet apart, and no

standing or overflow attendance will be permitted. As such, capacity will be limited to 100 persons.

- Chairs will be available on a first-come, first-served basis, and members of the public who do not arrive in time to get a chair will be required to leave the premises.
- Any person who refuses to strictly adhere to these measures will be required to leave the premises.

For the protection of your own health and the health of others related to the spread of COVID-19, the City urges you to consider other options for public participation first, and to consider the risks involved with the in-person Community Center option, before making a decision to participate in the hearing via the Community Center option.
