## A RESOLUTION OF THE CARSON CITY COUNCIL TO AMEND THE FISCAL YEAR 2021-22 BUDGET IN THE PROPOSITION C AND AIR QUALITY FUNDS TO ALLOCATE ADDITIONAL FUNDING FOR THE PURCHASE OF TWO ELECTRIC VEHICLE MINIBUSES

WHEREAS, the City Council adopted the City's Fiscal Year (FY) 2021-22 budget on June 15, 2021 for the General Fund and Special Revenue Funds of the City via Resolution No. 21-073; and

WHEREAS, during the FY 2021-22 budget cycle, a total of \$200,000 was budgeted evenly between Proposition C account no. 219-90-940-180-8003 and Air Quality account no. 225-90-940-276-8003 as a prospective budget for the purchase of one (1) electric vehicle (EV) minibus; and

WHEREAS, in an effort to purchase two (2) EV minibuses, additional budget appropriations are needed in the two accounts; and

WHEREAS, the City Council desires to amend the FY 2021-22 budget.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF CARSON DOES HEREBY RESOLVE, FIND, DETERMINE, AND ORDER AS FOLLOWS:
