

**RESOLUTION NO. 22-059**

**A RESOLUTION OF THE CITY OF CARSON CITY COUNCIL**

**APPROPRIATION OF AMERICAN RESCUE PLAN ACT FUNDS**

WHEREAS, the American Rescue Plan Act provides Coronavirus State and Local Fiscal Recovery Funds (SLRF) to local governments such as the City of Carson address immediate and emergency needs related to COVID-19, including replenishing staffing shortages, premium pay for employees and elected officials who worked during the pandemic, providing infrastructure and capital improvements, and assistance for local business and residents; and

WHEREAS, in addition to expenditures on City infrastructure and capital improvements and other allowable expenditures to improve the community and provide for residents, the City desires to utilize a portion of the SLRF to replenish General Funds used to pay employee salaries during the mandated City furloughs.

WHEREAS, the City Council has determined it necessary to amend the FY 21-22 Budget. NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF CARSON DOES HEREBY RESOLVE, FIND, DETERMINE, AND ORDER AS FOLLOWS:

**Section 1.** The following budget transfer are as follows thereby amending the City's FY 21-22 budget.

Balance for EOC	<b>\$330,634.45</b>

**Section 2.** The City Clerk shall certify to the adoption of this resolution and shall keep a copy of this resolution attached to the FY 21-22 budget on file, and effective as of April 5<sup>th</sup>, 2022, the same shall be in force and effect.
