## **RESOLUTION NO. 22-083**

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF CARSON, CALIFORNIA, AMENDING THE CLASSIFICATION PLAN, RESOLUTION NO. 77-111, BY RECLASSIFYING ONE PART-TIME RECREATION COORDINATOR POSITION (TM PCN 303662284) INTO COMMUNITY SERVICES COORDINATOR I & II (YOUTH & FAMILY) JOB SERIES - A NEW CLASSIFICATION (CITY COUNCIL)

WHEREAS, the Meyers-Milias-Brown Act (the MMBA) (Government Code § 3500 et seq.) imposes on public employers and recognized employee organizations a "mutual obligation" to meet and confer regarding wages, hours, and other terms and conditions of employment, and thereby freely exchange information, opinions, and proposals to reach an agreement on matters within the scope of representation; and

WHEREAS, Assistant City Manager Robert Lennox is authorized and directed under provisions of Sections 2797.1 of the Carson Municipal Code and Section II, Rule II of the City Personnel Rules to prepare and recommend position classification and compensation plans, after consultation withthe affected Directors, which becomes effective upon approval by the City Council; and

**WHEREAS**, Rule III of the City of Carson Personnel Rules provides that modification to the classification plan, embodied in Resolution No. 77-111, shall be made only after the authorized Human Resources & Risk Management staff members consults with the affected Directors and affected recognized employee organizations; and

WHEREAS, the City of Carson desires to add a new classification specification of COMMUNITY SERVICES COORDINATOR I & II (YOUTH & FAMILY) JOB SERIES to provide a current and accurate description of the various duties performed by said position; and

WHEREAS, the City of Carson agrees with Human Resources & Risk Management staff recommendations to compensate the new COMMUNITY SERVICES COORDINATOR I & II (YOUTH & FAMILY) JOB SERIES classification in line with other Coordinator job series, within the same department, level positions at Range 721 for Level I and Range 715 for Level II, of the most recently published American Federation of State, County And Municipal Employees, Local 809 for Full-time employees; and

WHEREAS, Assistant City Manager Robert Lennox has consulted with the affected parties, and has met and conferred with the representatives of the affected recognized employee organizations pursuant to its obligations under the MMBA, concerning the revised classification specification for the COMMUNITY SERVICES COORDINATOR I & II (YOUTH & FAMILY) JOB SERIES.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF CARSON, CALIFORNIA, HEREBY FINDS, DETERMINES AND RESOLVES AS FOLLOWS:

**Section 1.** The above recitals are true and correct.

Section 2. The new classification specification for COMMUNITY SERVICES COORDINATOR I & II (YOUTH & FAMILY) JOB SERIES [Salary Range 721: \$5,323.00 - \$6,780.00 (for Level I of the job series); and, Salary Range 715: \$5,589.00 - \$7,122.00 (for Level II of the job series)], attached hereto as Exhibit A, assigned to the American Federation of State, County And Municipal Employees, Local 809 Full-time Employees (AFSCME 809 FT), is hereby adopted.

Section 3. The City will reclassify one Recreation Coordinator Part-time position (TM PCN 303662284) into the new classification of COMMUNITY SERVICES COORDINATOR I & II (YOUTH & FAMILY) JOB SERIES.

**Section 4.** The City will reclassify the current incumbent within the reclassified Recreation Coordinator part-time position (EID 69514) into Level I of the newly adopted **COMMUNITY SERVICES COORDINATOR I & II (YOUTH & FAMILY) JOB SERIES**, with the impacted employee retaining seniority dates and salary step placement, effective May 4<sup>th</sup> of 2022.

**Section 5**. The City Clerk shall certify to the adoption of this resolution anddeem it effective as of May 3<sup>rd</sup> of 2022 the same shall be in force and effect.
