RESOLUTION NO. 22-109

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF CARSON, CALIFORNIA, AMENDING THE CLASSIFICATION PLAN, RESOLUTION NO. 77-111, BY ADOPTING A NEW JOB CLASSIFICATION SPECIFICATION AND SALARY ALLOCATION FOR ASSISTANT COMMUNITY SERVICES COORDINATOR (SENIOR SERVICES) (CITY COUNCIL)

WHEREAS, the Meyers-Milias-Brown Act (the MMBA) (Government Code § 3500 et seq.) imposes on public employers and recognized employee organizations a "mutual obligation" to meet and confer regarding wages, hours, and other terms and conditions of employment, and thereby freely exchange information, opinions, and proposals to reach an agreement on matters within the scope of representation; and

WHEREAS, Assistant City Manager Robert Lennox is authorized and directed under provisions of Sections 2797.1 of the Carson Municipal Code and Section II, Rule II of the City Personnel Rules to prepare and recommend position classification and compensation plans, after consultation withthe affected Directors, which becomes effective upon approval by the City Council; and

WHEREAS, Rule III of the City of Carson Personnel Rules provides that modification to the classification plan, embodied in Resolution No. 77-111, shall be made only after the authorized Human Resources & Risk Management staff members consults with the affected Directors and affected recognized employee organizations; and

WHEREAS, the City of Carson desires to add a new classification specification of ASSISTANT COMMUNITY SERVICES COORDINATOR (SENIOR SERVICES) to provide a current and accurate description of the various duties performed by said position; and

WHEREAS, the City of Carson agrees with Human Resources & Risk Management staff recommendations to compensate the new ASSISTANT COMMUNITY SERVICES COORDINATOR (SENIOR SERVICES) classification in line with other Assistant Coordinator, within the same department, level positions at Range 726 of the most recently published American Federation of State, County And Municipal Employees, Local 809 for Full-time employees; and

WHEREAS, Assistant City Manager Robert Lennox has consulted with the affected parties, and has met and conferred with the representatives of the affected recognized employee organizations pursuant to its obligations under the MMBA, concerning the new classification specification for the ASSISTANT COMMUNITY SERVICES COORDINATOR (SENIOR SERVICES).

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF CARSON, CALIFORNIA, HEREBY FINDS, DETERMINES AND RESOLVES AS FOLLOWS:

- **Section 1.** The above recitals are true and correct.
- Section 2. The new classification specification for ASSISTANT COMMUNITY SERVICES

COORDINATOR (SENIOR SERVICES) (Salary Range 726, \$4,168.00 - \$5,306.00), attached hereto as <u>Exhibit A</u>, assigned to the American Federation of State, County And Municipal Employees, Local 809 Full-time Employees (AFSCME 809 FT), is hereby adopted.

Section 3. The City will fund one full-time position for the newly adopted classification of **ASSISTANT COMMUNITY SERVICES COORDINATOR (SENIOR SERVICES)**, through funds already allocated for the Community Services/Parks & Recreation Department.

Section 4. The City Clerk shall certify to the adoption of this resolution anddeem it effective as of June 21st of 2022 the same shall be in force and effect.
