## **RESOLUTION NO. 22-123**

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF CARSON, CALIFORNIA, CREATING A NEW JOB CLASSIFICATION OF DIRECTOR OF INFORMATION TECHNOLOGY & SECURITY AND AMENDING RESOLUTION 19-015 (CITY COUNCIL)

**WHEREAS,** Section 503 of the City's Charter provides that the City Council shall determine, by ordinance or resolution, the amount and type of compensation to be paid to all City officers, department heads and employees; and

WHEREAS, Assistant City Manager — Administrative Services Robert Lennox, acting as Director of Personnel, is authorized and directed under provisions of Sections 2797.1 of the Carson Municipal Code and Section II, Rule II of the City Personnel Rules to prepare and recommend position classification and compensation plans, after consultation with the department directors, which becomes effective upon approval by the City Council; and

WHEREAS, the City Council desires to add a new unrepresented at-will classification of DIRECTOR OF INFORMATION TECHNOLOGY & SECURITY, to serve as the head of the Information Technology & Security Department, and desires to adopt a classification specification to establish and describe the duties to be performed by said position and assign a salary range in line with other director-level positions within the City; and

WHEREAS, Assistant City Manager Robert Lennox has consulted with any affected recognized employee organizations pursuant to its obligations under the City's Personnel Rules and the MMBA, concerning the new classification of **DIRECTOR OF INFORMATION TECHNOLOGY** & SECURITY.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF CARSON, CALIFORNIA, HEREBY FINDS, DETERMINES AND RESOLVES AS FOLLOWS:

- **Section 1.** The above recitals are true and correct, and are incorporated herein by this reference.
- Section 2. The unrepresented at-will classification of DIRECTOR OF INFORMATION TECHNOLOGY & SECURITY is hereby created. The classification of DIRECTOR OF INFORMATION TECHNOLOGY & SECURITY shall be considered an exempt classification under the Fair Labor Standards Act (FLSA). The provisions of Carson Municipal Code Article II, Chapter 9 and the City's Personnel Rules shall not apply to the classification of DIRECTOR OF INFORMATION TECHNOLOGY & SECURITY.
- **Section 3**. The classification of **DIRECTOR OF INFORMATION TECHNOLOGY & SECURITY** shall be considered an Unclassified Management Employee. Article I, Section 4 of Resolution No. 19-015, "A Resolution of the City Council of the City of Carson, California Amending and Ratifying Resolution No. 18-170 Establishing the Salary and Benefits for

Unclassified Management Employees Effective December 4, 2018" shall be amended to add the **DIRECTOR OF INFORMATION TECHNOLOGY & SECURITY** classification to the list of Unclassified Management Employees.

- **Section 4.** The classification specification for **DIRECTOR OF INFORMATION TECHNOLOGY & SECURITY**, attached hereto as **Exhibit A** is hereby adopted.
- **Section 5.** The classification of **"DIRECTOR OF INFORMATION TECHNOLOGY & SECURITY"** is assigned to Salary Range 631 (TM: 304), \$12,128.00 15,478.00.
- **Section 6.** The City will fund one full-time position for the newly adopted classification of **DIRECTOR OF INFORMATION TECHNOLOGY & SECURITY**, through general fund.
  - **Section 7**. This resolution shall be effective July 1, 2022.
- **Section 8**. The City Clerk shall certify to the adoption of this Resolution and shall enter it into the book of original Resolutions.
