He stated Brenden will continually be involved in the project and Darren Embry as well.

Council Member/Agency Member/Authority Board Member Rojas stated she had another concern of the community Union South Bay Project that is 60% occupied and zero retail, not at 100%. The Imperial Avalon project has not started yet.

Darren Embry noted residential occupancy is 97.5% occupied at the Union South Bay.

Brenden stated Carson deserves better than basic and would rather be charged with waiting too long to find the right tenant then placing the wrong tenant there for the City to deal with a long period of time.

Council Member/Agency Member/Authority Board Member Rojas noted stipulations support the Country Mart. She requested the developer to make the warehouses look great like artwork such as waterfalls, lighting, green trucks, and charging stations.
