Item No. 5. 2022-522 PRESENTATION UPDATE FROM WEST BASIN MUNICIPAL WATER DISTRICT

Gregory Reed, General Manager of West Basin Municipal Water District, introduced himself and deferred to Harold Williams, Director of Division 1, who gave a PowerPoint presentation on "Let's Make Carson Super-Cali-Frugalistic" – Save Water. Save California.

Gregory Reed continued with the PowerPoint presentation.

Item No. 6. 2022-531 STATE OF CALIFORNIA LEGISLATIVE UPDATE FROM JOE A. GONSALVES & SON

Jason Gonsalves with lobbying firm Joe A. Gonsalves & Son, stated services with City began in March 2021 and provided an update as follows:

- Commenced the 2022 legislative session; February 18, 2022 was the deadline to introduce bills
- Legislature had 2,000 plus of all new pieces of legislation
- May 27, 2022 was the House of Origin deadline meaning all the Assembly Bills had to pass out of the Assembly and all Senate Bills had to pass out of the Senate by way of the deadline. There is about under 1,000 bills remaining.
- Legislature is continuing to work in a hybrid fashion meaning they are allowing for minimal in-person participation and remote testimony
- June 30, 2022 Policy Committee deadline in the House of Origin
- Legislature in summer recess from July 1, 2022 to August 1, 2022
- About 1,000 bills remaining
- August 1-31, 2022 remainder session for the year to continue to vet those 900 to 1,000 remaining bills
- Housing continues to be a leading issue for the Governor and the Legislature.
 Unfortunately, there is a trend that seeks to circumvent local land use authority and seeing a number of bills doing so and trend ongoing disagreement on labor protection for those building affordable housing and the like.
- Will continue to keep the City apprised on the various Housing Bills which there are about

- COVID-19 positivity rates continue to climb statewide; last Friday California hit a 10.5% positivity rate for the seven-day average
- Governor has rolled back a series of his Executive Orders; he stated only 5% of the Executive Orders will remain post June 30th; noted the State of the Emergency remains in place and the ability for Brown Act flexibility remote participation will also remain post June 30th
- State budget The Governor had a \$300 plus billion record proposal in May and of that \$300 billion, \$98 billion is the projected surplus; the Non-partisan Legislative Analyst Office ran 10,000 revenue forecast scenarios – 95% came back with a potential budget problem and or deficit beginning in 2025; June 15, 2022 is the constitutional deadline to pass the budget
- Cost of living relief that's being negotiated is a sticking point; the legislative leaders have proposed a \$200 relief check per tax filer and the Governor has proposed a \$400 relief check per vehicle registration up to two vehicles per individual
- Speaker of the assembly announced the formation of a Select Committee on gas supply
 pricing and Assembly Member Mike Gipson is a member who was appointed member of
 the committee giving timing July being summer recess back in August; the speaker
 projected Californians will see some relief before October
- Governor and Legislature navigate the ballooning surplus with the GANN limit and the very difficult budget years will likely see continued focus on a rainy-day fund as part of last year's budget

Jason Gonsalves thanked the Mayor and City Council for their leadership, management team for their direction and partnership, and privilege and honor to represent the City.
