RESOLUTION NO. 22-223

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF CARSON, CALIFORNIA, AMENDING THE FISCAL YEAR 2022-23 BUDGET, IN VARIOUS DEPARTMENTS, FOR THE ADJUSTMENT OF SALARIES AND BENEFITS OF PERSONNEL RESULTING FROM AMENDMENTS TO THE COMPENSATION RESOLUTION FOR UNCLASSIFIED MANAGEMENT EMPLOYEES.

WHEREAS, the City Council adopted the City's Fiscal Year (FY) 2022-23 budget on June 21, 2022; and

WHEREAS, the City of Carson desires to increase salaries and benefits per agreed upon memorandum of understanding from represented full time employees;

WHEREAS, the City Council desires to amend FY 2022-23 budget to authorize the use of funds from the Unreserved General Fund and Special Revenue and to appropriate additional salaries, retirement benefits, and Medicare benefits in each of the effected Department operating budgets.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF CARSON DOES HEREBY RESOLVE, FIND, DETERMINE, AND ORDER AS FOLLOWS:
