

RESOLUTION NO. 23-056

A RESOLUTION OF THE CARSON CITY COUNCIL AMENDING THE
FISCAL YEAR 2022-23 BUDGET IN THE TRANSPORTATION SERVICES
PROPOSITION C FUND FOR ADDITIONAL WORK RELATING TO
CITYWIDE BUS STOP IMPROVEMENTS

WHEREAS, the City Council adopted the City's Fiscal Year (FY) 2022-23 budget on June 21, 2022 for the General Fund and Special Revenue Funds of the City via Resolution No. 23-035; and

WHEREAS, the City Council approved a Public Works Agreement with ND Construction Company, Inc. for citywide bus stop improvements at the July 19, 2022 meeting; and

WHEREAS, over the course of the project, it was determined that additional sidewalk work was necessary to complete installations of new bus stop shelters; and

WHEREAS, the City Council desires to amend the FY 2022-23 Special Revenue Fund Proposition C budget for additional work relating to citywide bus stop improvements; and

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF CARSON DOES
HEREBY RESOLVE, FIND, DETERMINE, AND ORDER AS FOLLOWS:

Section 1. The following amendments will be made to the City's budget:
