

**RESOLUTION NO. 16-151**

**A RESOLUTION OF THE CITY OF CARSON CITY COUNCIL AMENDING THE  
FISCAL YEAR 2016-17 BUDGET IN THE GENERAL FUND AND SPECIAL  
EVENTS FUND**

WHEREAS, the City Council adopted the Fiscal Year 2016-17 (FY16-17) budget on June 21, 2016 for the General Fund and Special Revenue Funds of the City via Resolution No. 16-081; and

WHEREAS, on June 21, 2016, the City Council appropriated funding for City events scheduled July 2016 through December 2016; and

WHEREAS, on November 14, 2016, the City Council appropriated funding for City events scheduled January 2017 through June 2017, and requested additional information for various City programs/events; and

WHEREAS, the City Council desires to amend the FY16-17 budget to provide for additional City events; and

WHEREAS, the City Council has determined it necessary to amend the FY16-17 General Fund and City Events Fund budgets.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF CARSON DOES HEREBY RESOLVE, FIND, DETERMINE, AND ORDER AS FOLLOWS:

**Section 1.** The following amendment(s) will be made to the City's FY16-17 budget.
