# AMENDMENT NO. 1

### TO AGREEMENT FOR CONTRACTUAL SERVICES

THIS AMENDMENT TO THE AGREEMENT FOR CONTRACTUAL SERVICES ("Amendment") by and between the CITY OF CARSON ("City") and Swayzer Corporation, a Landscape ("Contractor") is effective as of the 1st day of July, 2016.

## RECITALS

- A. City and Contractor entered into that certain Agreement for Contractual Services dated <u>July 1, 2010 (</u> "Agreement") whereby Contractor agreed to provide <u>Center Median Landscape</u> Services.
  - B. City and Contractor now desire to amend the Agreement to <u>December 31, 2016</u>.

### **TERMS**

- 1. **Contract Changes**. The Agreement is amended as provided herein.
- A. Pursuant to Section 2, Contract Duration of the Agreement, City and Contractor exercised the option to extend the Agreement on June 4, 2013, for an additional term of three (3) years starting on July 1, 2013 and ending on June 30, 2016.
- B. Section 2, Contract Duration, shall be amended to read as follows:

"The contractor shall maintain all work under this contract for six (6) years from date of award, subject to a (6) month extension, upon the mutual written agreement of Contractor and City. Contract is subject to extension or termination as described in these Supplementary General Conditions, at including, but not limited to, Items 9 and 16.

- 2. **Continuing Effect of Agreement.** Except as amended by this Agreement, all provisions of the Agreement shall remain unchanged and in full force and effect. From and after the date of this Amendment, whenever the term "Agreement" appears in the Agreement, it shall mean the Agreement, as amended by this Amendment to the Agreement.
- 3. Affirmation of Agreement; Warranty Re Absence of Defaults. City and Contractor each ratify and reaffirm each and every one of the respective rights and obligations arising under the Agreement. Each party represents and warrants to the other that there have been no written or oral modifications to the Agreement other than as provided herein. Each party represents and warrants to the other that the Agreement is currently an effective, valid, and binding obligation.

Contractor represents and warrants to City that, as of the date of this Amendment, City is not in default of any material term of the Agreement and that there have been no events that, with the passing of time or the giving of notice, or both, would constitute a material default under the Agreement.

City represents and warrants to Contractor that, as of the date of this Amendment, Contractor is not in default of any material term of the Agreement and that there have been no events that, with the passing of time or the giving of notice, or both, would constitute a material

default under the Agreement.

- 4. **Adequate Consideration.** The parties hereto irrevocably stipulate and agree that they have each received adequate and independent consideration for the performance of the obligations they have undertaken pursuant to this Amendment.
- 5. **Authority.** The persons executing this Agreement on behalf of the parties hereto warrant that (i) such party is duly organized and existing, (ii) they are duly authorized to execute and deliver this Agreement on behalf of said party, (iii) by so executing this Agreement, such party is formally bound to the provisions of this Agreement, and (iv) the entering into this Agreement does not violate any provision of any other Agreement to which said party is bound.
