

RESOLUTION NO. 17-060

A RESOLUTION OF THE CARSON CITY COUNCIL AMENDING THE FISCAL YEAR 2016-17 BUDGET IN THE GENERAL FUND BY APPROPRIATING \$24,999 FOR CONTRACT SERVICES WITH JASMYNE CANNICK

WHEREAS, the City Council adopted the Fiscal Year 2016-17 (FY16-17) budget on June 21, 2016 for the General Fund and Special Revenue Funds of the City via Resolution No. 16-081; and

WHEREAS, an amendment to the general fund budget in the amount of \$24,999 to fund the contract between the City of Carson and Jasmyne Cannick to perform media relations and public affairs services as requested by the City, on an on-call basis, including, but not limited to the update to the EIR for the 157 – acre property as part of the requirements of the Macerich fashion outlet retail center project, the City's housing of military veterans, the relocation of the NFL Chargers team to the StubHub venue and the City's 50th anniversary celebration, and other activities; and

WHEREAS, the City Council desires to amend FY 2016-17 budget.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF CARSON DOES HEREBY RESOLVE, FIND, DETERMINE, AND ORDER AS FOLLOWS:

Section 1. The following amendments will be made to the City's budget:
