- **Section 3.** The class specification for HOUSING AND DEVELOPMENT PROGRAM MANAGER, (Salary Range 165 \$8,287 \$10,574) assigned to the Carson Professionals and Supervisors Association (CPSA), is hereby adopted.
- Section 4. The reclassification of one Redevelopment Program Analyst to Housing and Development Program Manager (Salary Range 165 \$8,287 \$10,574) is hereby adopted.
