## **RESOLUTION NO. 17-24-CHA**

## A RESOLUTION OF THE CARSON HOUSING AUTHORITY AMENDING THE FISCAL YEAR 2017-18 BUDGET IN THE CARSON HOUSING AUTHORITY FUND

WHEREAS, the Carson Housing Authority adopted the Fiscal Year 2017-18 (FY17-18) budget on June 20, 2017 for the Carson Housing Authority Fund via Resolution No. 17-16-CHA; and

WHEREAS, the Carson Housing Authority (Authority) is demolishing the property located at 21723-21725 Figueroa Street (Demolition Project) in preparation for the development of an affordable housing project for veterans of the United States Armed Forces; and

WHEREAS, on July 18, 2017, the Authority adopted Resolution No. 17-19-CHA, amending the FY17-18 Carson Housing Authority Fund budget to include the funds for the Demolition Project in the amount of \$54,243; which included the bid amount of \$47,168 and a contingency amount of \$7,075 (Contingency Funds) (15% of the bid amount).

WHEREAS, the Contingency Funds have been used to cover costs during asbestos abatement; and

WHEREAS, this resolution is to appropriate \$8,000 to provide additional funds to cover any contingencies that may arise during demolition work.

NOW, THEREFORE, THE CARSON HOUSING AUTHORITY DOES HEREBY RESOLVE, FIND, DETERMINE, AND ORDER AS FOLLOWS:

Section 1. The following amendment(s) will be made to the Authority's FY17-18 budget.
