Captain Skeen reported that he was working with City management and other stakeholders for a security plan at StubHub in preparation for the potential Chargers coming in August. He announced the following: 1) Sponsoring a day at the Animal Shelter in Carson/Gardena in which 30 dogs were adopted; 2) Bone Marrow Drive at Sheriff Station tomorrow; 3) Literacy Program at Stephen White Middle School; met with Dr. Brown, Principal; and 4) Explorer Graduation; new class beginning in March.

Council Member/Agency Member/Authority Board Member Santarina thanked Captain Skeen for being a good columnist and referred to the Captain's Corner section of the Carson Report which is a must read for everyone.
