(street) between LYNSANDER and TAMCLIFF, do hereby petition the City of Carson to consider the establishment of a Preferential Permit Parking Zone on both sides of the street in accordance with the provisions of Carson Municipal Code Chapter 2.5. We request that the preferential parking restrictions be imposed to prohibit parking [AT ALL TIMES] or [FROM ____ AM/PM TILL ____ AM/PM] (Circle one) on the following days of the week [Mon Tues Wed Thurs Fri Sat Sun] (Circle the days) unless a City-issued permit is displayed. It is agreed that the residents are willing to pay all administrative costs associated with the permit parking zone, which includes the installation of signs and the printing and distribution of permits. A maximum of three permits may be issued for any single residence for motor vehicles registered at the residence and up to two visitor permits may be issued to any one residence.

Subsequent to the submittal of this petition with 60% approval by the residents, the request for permit parking will be presented to the Public Works Commission at a public hearing and the Commission will make a recommendation to the City Council.
