WHEREAS, Carson is a vibrant, economically growing City located in Los Angeles County, California, USA. It is a culturally diverse community with Filipinos occupying a good percentage of the population;

WHEREAS, a bonding tie of sisterhood between the City of Carson and the City Government of Paranaque will foster cooperative undertakings as well as mutual friendship and goodwill,

WHEREAS, the sisterhood pact will not only strengthen friendship ties but more importantly institute a working avenue of communication in facilitating exchange of information and technology, urban planning and development, socio-cultural activities, tourism, trade and other important aspects of local governance that are beneficial for both local government units;
