

RESOLUTION NO. 17-161

**A RESOLUTION OF THE CITY OF CARSON CITY COUNCIL
AMENDING THE FISCAL YEAR 2017-18 BUDGET IN THE
GENERAL FUND AND THE LOAD SHED FUND**

WHEREAS, the City Council adopted the Fiscal Year 2017-18 (FY17-18) budget on June 20, 2017 for the General Fund and Special Revenue Funds of the City via Resolution No. 17-068; and

WHEREAS, the City has a funding opportunity to fit all City street lights with LED lamps; and

WHEREAS, the City will need to fund the expenditures up front, then be reimbursed by Southern California Edison that will in-turn recoup its reimbursement costs by capturing the City's electric bill savings; and

WHEREAS, the City Council has determined it necessary to amend the FY17-18 budget in the General Fund and Load Shed Fund.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF CARSON, CALIFORNIA, DOES HEREBY RESOLVE, FIND, DETERMINE, AND ORDER AS FOLLOWS:

Section 1. The following amendment(s) will be made to the City's FY17-18 budget.
