

RESOLUTION NO. 17-131

**A RESOLUTION OF THE CITY OF CARSON CITY COUNCIL AMENDING THE
FY 2017/18 BUDGET IN VARIOUS FUNDS TO APPROPRIATE THE FY 2017/18
ROAD REPAIR AND ACCOUNTABILITY ACT PROJECT**

WHEREAS, the City Council adopted the FY 2017/18 budget on June 20, 2017 for the General Fund and Special Revenue Funds of the City via Resolution No. 17-068; and

WHEREAS, pursuant to the California Road Repair and Accountability Act of 2017, the City must adopt a budget for the project(s) to be funded from the Road Maintenance and Rehabilitation Account (RMRA); and

WHEREAS, on September 19, 2017, the City Council approved the staff recommendation to use the FY 2017/18 RMRA funding for a project to rehabilitate Turmont Street from Avalon Boulevard to Central Avenue; and

WHEREAS, also on September 19, 2017, staff reported that the City is estimated to receive \$542,032.00 of RMRA funding for FY 2017/18, and the Turmont Street project would need approximately \$1.6 million of funding, and staff recommended the funding be transferred from the FY 2017/18 appropriations for pavement slurry seal and overlay projects; and

WHEREAS, the City Council has determined it necessary to amend the FY 2017/18 budget.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF CARSON DOES HEREBY RESOLVE, FIND, DETERMINE, AND ORDER AS FOLLOWS:


