Program Consultant Miguel Rodriguez of MDG Consultants prepared bid packages for the above property on two (2) occasions. On the first bid process, staff received four bids of which only two were complete bids and one of the bidders removed his bid leaving only one complete bid. This necessitated rebidding the project. On the second bid process, we received two complete bids. The lowest responsible bid will be accepted in accordance to Procurement Standards 2 CFR Part 200.320 for the second bid process and based upon the steps described below that were taken to maximize obtaining bids.

The following is a summary of the steps taken during the bid process:

- 1. The owner was provided with a list of 4 contractors that had submitted an application to be placed on the City of Carson's Contractors List for Commercial Rehabilitation Program projects. SEE INTERESTED SERVICE PROVIDER LIST.
- 2. The owner contact all four of the contractors.
- 3. A pre-bid walk was conducted by Miguel G. Ramirez, Program Consultant, on Wednesday December 06, 2017 at 10:00 a.m. The bid packages were previously distributed by the owner directly to the contractors and Addendum #1 was forwarded to all four contractors on December 19, 2017. A total of four (4) contractors attended the job walk. SEE SIGN IN SHEET AND PRE-BID MEETING CHECKLIST.
- 4. The job walk attendees were instructed on the Federal Funding requirements including Davis-Bacon and Labor Compliance forms and procedures that apply to the project.
- 5. The bid due date was specified as Wednesday January 24, 2018 at 12:00 p.m., as shown in the Bid Specification Manual.
- 6. No communication was received by City staff from any of the attending contractors during the bid period.
- 7. Only two bids were submitted on January 24, 2018. SEE CITY OF CARSON BID REGISTER DATED 01/24/18. The bids were hand delivered to the City Clerk's Office prior to the bid opening time.
- 8. The City Clerk closed the bid submittal time at 12:00 p.m. No other bids were received by the City Clerk.
- 9. Lowest bidder was Ever Builders in the amount of \$198,320.00.

Please note that this project is being bid out in two Phases. Phase 1 will include all work that can be funded with CDBG funds (total \$198,320.00) and Phase 2 which cannot be paid with CDBG funds but will be paid with owners private funds (\$79,730.00). Due to Program funding limits, Phase 1 will include a grant from the City in the amount of \$95,000.00 and owner will contribute \$103,320.00 for a total Phase 1 budget of \$198,320.00.
