Our best practice is to conduct a monthly conference call discussing the grant activities with City staff. B&A can attend Council meetings upon request.





### **Developing and Submitting Grants**

Prior to writing an application, B&A will develop a Not-to-Exceed (NTE) quote outlining tasks, the time and cost for each task, and the assumptions about the project. B&A only charges for the actual time it takes to prepare an application, but the City is protected by the NTE quote. Unless there is a change in the scope of work, B&A absorbs any extra time and does not charge the City.

Our standardized process includes developing of a Timeline and Checklist (T&C) outlining all needed data, tasks, and responsibility for completion.
