

## RESOLUTION NO. 18-125

### A RESOLUTION OF THE CITY OF CARSON CITY COUNCIL AMENDING THE FISCAL YEAR 2018-19 BUDGET TO CONTINUE UNSPENT APPROPRIATIONS FROM FISCAL YEAR 2017-18

WHEREAS, the City Council adopted the Fiscal Year 2018-19 (FY18-19) budget on June 19, 2018 for the General Fund and Special Revenue Funds of the City via Resolution No. 18-069; and

WHEREAS, the FY17-18 budget included appropriations for non-recurring projects that have not been completed, as well as other unspent appropriations; and

WHEREAS, staff recommends to continue the unspent FY17-18 appropriations over to FY18-19; and

WHEREAS, the City Council has determined it necessary to amend the FY18-19 budget in various funds of the City.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF CARSON DOES HEREBY RESOLVE, FIND, DETERMINE, AND ORDER AS FOLLOWS:
