

RESOLUTION NO. 18-142

A RESOLUTION OF THE CARSON CITY COUNCIL AMENDING THE FISCAL YEAR 2018-19 BUDGET FOR THE NATE RIDDICK VOLUNTEER RECOGNITION BANQUET, MISS CARSON SCHOLARSHIP PAGEANT, CINCO DE MAYO, PHILIPPINE INDEPENDENCE DAY, JUNETEENTH, AND THE PARENT CONFERENCE

WHEREAS, the City Council adopted the City's Fiscal Year (FY) 2018-19 budget on June 19, 2018; and

WHEREAS, additional funds are needed to bring the budgets of the Nate Riddick Volunteer Recognition Banquet, Miss Carson Scholarship Pageant, Cinco de Mayo, Philippine Independence Day, Juneteenth and the Parent Conference at or near where they were before; and

WHEREAS, these moneys will also permit staff to present a program similar to what has been done in the past; and

WHEREAS, the City Council desires to amend the FY 2018-19 budget.
