RESOLUTION NO. 18-136

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF CARSON, CALIFORNIA, APPROVING THE TENTATIVE AGREEMENT FOR SUCCESSOR MEMORANDUM OF UNDERSTANDING (DEAL POINTS) BETWEEN THE CITY OF CARSON AND THE AMERICAN FEDERATION OF STATE, COUNTY AND MUNICIPAL EMPLOYEES UNION, LOCAL 809, FOR THE PERIOD OF JULY 1, 2016 to JUNE 30, 2021.

WHEREAS, the City of Carson (City) has and continued to recognize the American Federation of State, County and Municipal Employee (AFSCME), Local 809, as the sole exclusive bargaining agents for those City employees designated as being in the American Federation of State, County and Municipal Employee (AFSCME), Local 809, for all matters concerning wages, hours and working conditions; and

WHEREAS, the most current Memorandum of Understanding (MOU) expired between the City and AFSCME, Local 809, expired on June 30, 2016;

WHEREAS, the City labor relations representatives and AFSCME, Local 809 representatives have successfully met and conferred to negotiate a successor MOU between the parties pursuant to both the Meyers-Milias-Brown Act (MMBA) (Government Code Sections 3500-3511) and the City's Employer-Employee Relation Resolution No. 85-107, and have jointly prepared and executed the attached Tentative Agreement For A Successor MOU (deal points) between the City and AFSCME, Local 809, for the period July 1, 2016 through and including June 30, 2021, subject to City Council determination and approval, which is made a part hereof by this reference; and

WHEREAS, MMBA Section 3505.1 provides that: "If a tentative agreement is reached by the authorized representatives of the public agency and a recognized employee organization, the governing body shall vote to accept or reject the tentative agreement within 30 days of the date it is first considered at a duly noticed public meeting. If the governing body adopts the tentative agreement, the parties shall jointly prepare a written memorandum of understanding."; and

WHEREAS, the City labor relations representatives and AFSCME, Local 809 representatives have agreed to prepare and execute a final successor MOU between the City and AFSCME, Local 809 for the period of July 1, 2016 through and including June 30, 2021. The most current Memorandum of Understanding (MOU) expired between the City and AFSCME, Local 809 expired June 30, 2016.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF CARSON, CALIFORNIA, HEREBY FINDS, DETERMINES AND RESOLVES AS FOLLOWS:

Section 1. The above recitals are true and correct.

Section 2. The City Council approves the Tentative Agreement For A Successor MOU between the City and AFSCME, LOCAL 809 for the period of July 1, 2016 through and including June 30, 2021, a copy of which is attached as Attachment 1.

Section 3. The City Clerk shall certify to the passage and adoption of this Resolution and enter it into the book of original resolutions.

Section 4. This resolution shall be effective immediately upon is passage and adoption.
